Council arranges the contractor to cleanout the solids tank. Your assistance in providing detailed information about your premises and the location of tanks will enable the Contractor to assess the site for access.

The service will be conducted by either a 6 wheel (23 ton) or 8 wheel (25 ton) truck. Access by either of these vehicles to a point within 30 metres of the collection tank will be required together with an adequate turning circle for the truck, in order to perform this service.

Although customers are not required to be onsite, there will be a need to provide Council's Contractor with clear access to the tanks.

Should you wish to be present at the service, please indicate in the Property Details section. Premier Pumpouts will contact you to make the necessary arrangements.

- Council's Contractor is required to fill the tank with water from the customer's supply, to a level to prevent the tank from moving. Water used is at owners expense.
 - Customers are responsible to ensure installation of tanks including anchor points accords with AS/NZ S 1546.1:1998 prior to the service being performed. A copy is available upon request.
